**INSTRUCTIONS**

2. Complete form below, including certification, in accordance with instructions. Any ad in violation of these instructions will not be published.
3. Appropriate fee must accompany this form. Payment may be made by check/money order, debit from an LFCU account or by cash. Cash will not be accepted by mail.
4. To advertise in the Bulletin, you must be a current LFCU member or eligible for membership in LFCU.
5. LFCU retains the right to reject incomplete/incorrect ads, ads for employment, services that conflict with those provided by LFCU or LFS, LLC, or ads not considered appropriate.

**COST**

An eighth-page ad costs \$60.00 per Bulletin issue. Please choose one of the following options. If you pre-pay for more than one issue, the fee is non-refundable should you decide to cancel. Pre-paid ads must run in consecutive issues.
